## NR Edit

Nominal Roll Edit based on the results of October 2024 (including readmission, institution transfer and malpractice candidates) can be downloaded from the dipexamstndte.in portal using the following module:

Pre-Examination > Download NR Edit

As resolved in the 60<sup>th</sup> Meeting of Board of Examinations and communicated by this office letter no: 106251/M1/2023 dated 30.03.2023, candidates who have secured attendance between 50 and 65 percent shall be permitted to proceed to next semester (only one time during the course of study) considering the subjects of current semester as arrears.

The names of such students (i.e. who have attendance between 50 and 65 percent in October 2023 Board Examinations, including those not remitted October 2024 Board Examination Fees) are also included in the Apr 2025 NR Edit.

Students can avail each clause of attendance condonation i.e. between 50 to 65 percent and between 65 to 75 percent <u>only once</u> during their entire course of study.

#### Registration of Candidates by Institutions (without Fine)

Registration of Candidates by Institutions can be done in the dipexamstndte.in using the following module:

This module has the following options:

The downloaded CSV file has the following columns/heading:

- REGNO (Register Number)
- NAME (Name of the Candidate)
- NCNO (Course Code)

- LASTAPPR (O23 for Oct 2023, A23 for Apr 2023, O22 for Oct 2022 ...)
- EXAMFEE (Examination Fees)
- FEEPAID (Y if the candidate paid the exam fees, N otherwise)

If any of the eligible candidates in the CSV file have not remitted Examination Fees without Fine, change FEEPAID flag from Y to N. Add the details of the eligible candidates (including examfee and feepaid status) who have not appeared in Oct 2024 (i.e. additional nominal roll). Before uploading take a print out of the CSV file and verify it throughly.

Before taking final copy, please verify the Draft Copy in all aspects. After taking Final Copy, the module will be freezed and Upload CSV & Clear Registrations options will be disabled. No request for corrections / addition / deletion in Registration of Candidates will be entertained at later stage. Do not include any other additional column such as serial number etc. OR change the column name/heading.

## Payment of Fees (without Fine only) by Institutions

The institutions after finalizing the Registration of Candidates (without fine), are requested to pay the Examination Fees (including the amount collected for combined marksheet) through

Government, Aided & Self-Financing Polytechnic Colleges

• through online payment gateway available in the DipExOnline portal.

# Payment of Examination Fees by Indian Bank MU Chalan OR in any other mode will not be permitted for all Institutions (Government, Aided & Self Financing).

#### Expenditure incurred in printing Soft Copy of Combined Marksheets

To compensate the expenditure incurred in printing of Combined Marksheets for the Oct 2022, Apr 2023 and Oct 2023 Board Examinations will be automatically calculated and adjusted while paying April2025 Examination fees.

Necessary instructions to reimburse the expenditure incurred in printing Apr 2024, Oct 2024 and Apr 2025 Combined Marksheets will be issued as a separate circular.

Registration of Candidates with Fine (Rs. 150) & Tatkal Fine (Rs. 750)

Institutions can register the candidates for the period without fine only. After 21.03.2025, Institutions cannot register candidates. Only candidates will be permitted to register (i.e. from 22.03.2025 – with fine & from 29.03.2025 - with

tatkal fine) in the dipexamstndte.in portal and pay the examination fee directly using the online payment gateway.
